### From Route 128:

- Rte. 24 South 23.5 miles to Rte. 140 (Exit 12)
- Rte. 140 South 19.1 miles to Rte. 6
- Turn right onto Rte. 6, travel 6/10 of a mile to 2nd set of lights
- Turn right onto Slocum Road, travel 1/10 of a mile to club entrance on left



### From Route 195:

- Rte. 140 (Exit 13A) 1.1 miles to Rte. 6
- Continue same as above.

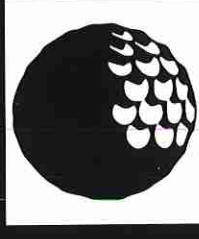
### PROPER ATTIRE REQUIRED
