
# The Arc of Bristol County proAbility Sets the Standard with Near-Perfect DDS Rating

In March 2025, The Arc of Bristol County proudly achieved an impressive overall organizational rating of 99% during the Department of Developmental Services (DDS) Office of Quality Enhancement licensure and certification review. The DDS service providers must undergo licensing every two years across various service groups, including Residential (ABI and Turning 22), Individual Home Supports, Placement Services (Shared Living), Remote Monitoring, Employment, and Day Supports. The licensure review is a comprehensive process emphasizing essential safeguards such as personal and environmental safety, effective communication, health considerations, human rights, a competent, skilled workforce, and the development and implementation of individual goals.

In addition to the licensure expectations, the review process encompasses certification indicators assessing universal service expectations and organizational standards. The Arc of Bristol County's focus on quality improvement initiatives, fostering supportive relationships, and promoting meaningful activities and community integration were key areas of evaluation relative to these certification indicators.

Achieving a 99% score during this review cycle is a testament to The Arc of Bristol County's unwavering commitment to providing exceptional services to the individuals and families it supports. This accomplishment reflects the agency's dedication to quality and reinforces its mission to enhance the lives of those served.



#### **Advocacy in Action: State and National Highlights**

This spring, The Arc of Bristol County participated in major advocacy events at both the state and national levels. On March 6, over 600 advocates gathered at the Massachusetts State House for the 47th Annual Legislative Reception—the largest IDD and autism advocacy day in the state. With the theme "Safeguarding Our Rights through Advocacy,"

the event highlighted key issues, including education, fair wages, and healthcare.

Just weeks later, from April 7–9, over 900 advocates, including 70 from Massachusetts, came together in Washington, D.C. for the 2025 Disability Policy Seminar. After two days of expertled sessions, advocates met with lawmakers on Capitol Hill to

push for critical policy changes.

In early June, proAbility staff joined over 300 Rhode Islanders to rally and advocate for the protection of services statewide.

We thank all who represented The Arc of Bristol County dba proAbility at these events and continue to prioritize disability rights at every level.





#### **Expanding Employment Services through Virtual Reality**

At The Arc of Bristol County proAbility, we harness Virtual Reality (VR) to help individuals with intellectual and developmental disabilities (I/DD) develop essential workplace skills. Since 2016, proAbility has provided employment supports in Rhode Island. In 2024, we expanded into Massachusetts to help even more people in Bristol County find jobs that include everyone.

With VR technology, people can safely practice real job tasks in a fun and realistic setting. They can try things like customer service or working in a factory—without the pressure of a real job.

This kind of training builds confidence and helps people feel ready to work. By using new technology, The Arc of Bristol County proAbility is opening doors to more



job opportunities and independence for people of all abilities.

### The Arc Partners with New Hope to Support Survivors with Disabilities

The Arc of Bristol County is proud to partner with New Hope, a domestic and sexual violence agency, on a federally funded project through the Office on Violence Against Women. This initiative is part of the Disability Grant Program, which works to improve how organizations support people with disabilities and Deaf individuals who experience sexual or domestic violence.

This collaboration will focus on educating staff, individuals, and families about the high rates of violence against people with disabilities, and on steps we can take to reduce those risks.


The Arc of Bristol County has welcomed Emily Lucas, MPA, as

### New Voices, New Energy: How Young Advocates Are Sparking a Self-Advocacy Revival

proAbility self-advocates began monthly meetings in late winter. These sessions were productive, with attendees deciding on the following topic each time. They have discussed human rights, elections, and the appropriateness of political discussions. The meetings emphasize that differing viewpoints and values are helpful and necessary.

The proAbility self-advocates include about twenty individuals, with around ten attending each meeting. Meetings are scheduled on alternating days to accommodate participants' varied schedules.

The revival of the self-advocacy group sparked a proposal for a spin-off focused on self-care, particularly relationships. This idea emerged from an individual seeking a romantic

partner and wishing to learn how to navigate that process. Currently named Self-Care Groups, they are organized by gender to encourage open discussion on hygiene, body image, and health issues specific to each gender.

The Self-Advocacy and Self-Care Groups are led by DSPs and driven by participants, with coordinators attending the meetings to offer support as needed. According to Sandy Nardillo, Assistant Director of Community Supports, the engagement and participation have been amazing, fueled by the participants' excitement and energy. # Embracing Neurodiversity: A Family's Story of Advocacy, Autism, and Community

The Arc's mission emphasizes creating opportunities for growth and innovation through its services. We are inspired to share how the Family Support Center family has evolved and embraced neurodiversity.

"Before Tress, I didn't know anyone with ASD," said Erica, Tress's mom. "Tress has opened our eyes to the world, and I wouldn't change a thing!"

The Arc's Family Support Center has supported Tress and his family since childhood. Tress is now a teenager with autism. His mother, Erica, shared how she recognized his challenges with emotional self-regulation and overstimulation as a child, often intervening before public meltdowns. Tress struggled, preferred to play alone, and ignored classmates who would say "Hi!" in public.

There were no therapies that helped Tress feel more comfortable in social settings. They would plan to include Tress in attending social gatherings, explaining that all outings would not be his type of fun. "We would leave early or change plans if he had a hard time. We adapted and would try again next time," Erica said.

With his family's support, Tress formed genuine social connections in the 5th grade when he became involved in the school band. His mom recalls all the activities the band participates in outside of school; Concert performances, movie nights, Bands-Giving, a trip to Disney in 2023, and Texas in 2025. Through these outings, Tress interacts with peers regularly and thrives in social settings.

"Band opened a whole new world for him. He has been in the band since 5th grade, but it all clicked for him socially in 9th grade when the band started playing at the football games," Erica said. Tress performed at football games with the Concert Band, advanced to the Symphonic Band, and now participates in the Ensemble Band weekly after school. He spends quality time with his peers in band. "They watch out for him but treat him just like everyone else—even the football players!"

Kelly Ledoux, Director of Family Support, notes that Tress's engagement through social outings with The Arc has also increased over the last year. The Arc offers Respite Innovations Outings for caregivers of children aged 16-22 to address caregiver burnout by providing opportunities for children to attend various weekend activities. These activities, funded by the Massachusetts EOHHS, include outings like sporting events and interactive museum tours.

Erica reports that Tress particularly enjoys Family Support Center outings that include meals at restaurants. In addition, Ledoux noted Tress's excitement at a Providence College Women's Basketball Game this past winter. The Arc was seated near the college band, and Tress was thrilled.



Erica and her family value the support from The Arc's Family Support Center. Agencies like The Arc, are "here to help, so reach out," Erica advises. She also reinforced strong guardian advocacy: "No one knows your child like you. Trust your instincts. You are your child's biggest advocate!"

In closing, Erica states that Tress's social growth, challenges, and experiences have positively impacted the family. "We realize that everyone, disabilities or not, is different and unique. We need to accept them for who they are."
